STATUS REPORT


Comes now Central Jefferson County Utilities, Inc. (Central Jefferson) and, on its behalf and on behalf of the Office of the Public Counsel, Raintree Plantation, Inc., Jeremiah Nixon, Kenneth McClain, Norville McClain (Deceased) and the Norville McClain Trust, states as follows to the Missouri Public Service Commission (Commission):

1. The Commission's Order Directing Filing of a Joint Status Report issued July 29, 2008, directed that the parties shall jointly file, with the Commission, a status report regarding this matter by August 8, 2008.
2. Raintree Plantation, Inc., Jeremiah Nixon, and Kenneth McClain filed motions to dismiss with the Commission on May 21, 2007. Norville McClain (Deceased) and the Norville McClain Trust filed a motion to dismiss on June 4, 2007.
3. The Staff filed its response to these motions to dismiss on June 15, 2007. Jeremiah Nixon, Kenneth McClain and Raintree Plantation filed their reply to the Staff pleading on June 22, 2007.
4. While the Commission later ruled on a Staff motion for summary determination (October 4, 2007), it has not yet ruled on the motions to dismiss.

5. The motions to dismiss raise basic questions of jurisdiction. Accordingly, a ruling on those motions is necessary before the case can progress in a meaningful manner.

WHEREFORE, Central Jefferson respectfully requests the Commission consider this pleading to comply with the Commission's Order Directing Filing of a Joint Status Report.
