Pursuant to 4 CSR 240-2.060(5) and 4 CSR 240-3.545(20), CenturyTel Solutions, LLC respectfully requests that the Missouri Public Service Commission ("Commission") approve use of the fictitious name of CenturyLink Solutions.

CenturyTel Solutions, LLC's approved tariffs are currently on file with the Commission. CenturyTel Solutions, LLC is in compliance with any applicable Annual Report requirements, and Missouri USF and Commission assessments.

CenturyTel Solutions, LLC d/b/a CenturyLink Solutions is properly registered with the Missouri Secretary of State's office, and is "Active and in Good Standing" with that office. As required by 4 CSR 240-2.060(5)(B), evidence of registration of the fictitious name, CenturyLink Solutions, with the Secretary of State is attached.
