**AMERENUE'S RECOMMENDATION FOR NOTIFICATION TO DEXTER  
CUSTOMERS OF CORRECTED LOCAL PUBLIC HEARING LOCATION**

COMES NOW Union Electric Company d/b/a AmerenUE (AmerenUE) and for its *Recommendation For Notification To Dexter Customers Of Corrected Local Public Hearing Location* states as follows:

1. On November 5, 2009, the Commission issued an order setting local public hearings regarding AmerenUE's request for a general rate increase for retail electric service. That order scheduled a local public hearing on January 5, 2010, at the National Guard Armory in Dexter, Missouri. That order contained an incorrect address for the Armory.

2. AmerenUE has already provided notice to its customers using the incorrect address for the hearing in Dexter. In an effort to make its customers aware of the correct address for the hearing on January 5, 2010, AmerenUE makes the following recommendations:

- a. AmerenUE will publish an advertisement communicating the corrected address for the hearing in the local Dexter newspaper, prior to the hearing;
- b. AmerenUE will issue a media release to Dexter media outlets containing the corrected address prior to the hearing;

- c. Ameren UE will post a sign on the incorrect location to direct its customers to the correct location; and
- d. AmerenUE will station a person at the incorrect location for 30 minutes prior to the commencement of the hearing to direct customers to the correct location for the hearing.

3. AmerenUE has discussed this Recommendation with attorneys for the Commission Staff and Office of the Public Counsel, and is authorized to represent that they concur with this Recommendation.

WHEREFORE, AmerenUE respectfully requests that the Commission accept this Recommendation.
