**RESPONSE OF PLATTE-CLAY ELECTRIC COOPERATIVE, INC.
TO APPLICATION OF PRO BUILDERS SINCE 1994, LLC**

COMES NOW Platte-Clay Electric Cooperative, Inc., ("Platte-Clay") by and through its undersigned counsel, and for its response to the Application of Pro Builders Since 1994, LLC (hereinafter "Pro Builders") for Change of Electric Supplier, respectfully states as follows:

1. Platte-Clay is without information to confirm or deny Pro Builders' allegations regarding an estimate from Kansas City Power and Light to construct three-phase power.
2. Platte-Clay affirms that it provided an initial rough estimate of \$5,000.00 to construct three-phase power to Pro Builders. Platte-Clay further states that, after meeting with Pro Builders on or about October 5, 2018 and being fully informed of the desired size of service requested, a revised estimate of \$9,055.00 was provided to Pro Builders.
3. Platte-Clay affirms that it anticipates construction of such three-phase to take approximately four weeks. Platte-Clay is without information to confirm or deny Pro Builders' allegations regarding estimated construction time of Kansas City Power and Light.

4. Platte-Clay takes no position on the sufficiency of Pro Builders' complaint for satisfaction of the statutory standard for approval of a change of electric supplier.
5. Platte-Clay affirms that it has existing three-phase power across Pro Builders' property and along 45 Highway and that such three-phase is capable of serving Pro Builders.
6. Platte-Clay affirms that if Pro Builders' application is approved, Platte-Clay has sufficient ability to become Pro Builders' electric supplier.
7. Platte-Clay is without information to confirm or deny all remaining allegations contained in Pro Builders' Application.
