

**ORDER RECOGNIZING ADOPTION NOTICE**

In an Order issued on February 4, 1999, the Commission approved the sale and transfer of stock and control of Capital Utilities, Inc. (CU), Riverside Utility Company, Inc. (RU) and Foxfire Utility Company, Inc. (FU) to AquaSource, Inc. The three companies were to be merged into three subsidiaries of AquaSource known as AquaSource/CU, Inc., AquaSource/RU, Inc. and AquaSource/FU, Inc., respectively. On March 26, AquaSource/RU, Inc. filed an Adoption Notice by which it adopted the tariffs of Capital Utilities, Inc., currently on file with and approved by the Commission. That Adoption Notice was assigned Tariff File No. 9900739 and bore an effective date of March 29.


On April 8, the Staff of the Public Service Commission (Staff) filed a memorandum indicating that it has reviewed the tariff filing and found that it is correct and complies with the Commission's order.

The Commission has reviewed the tariff filing and the Staff memorandum and has determined that the filing is in compliance with the Commission's order.

**IT IS THEREFORE ORDERED:**

1. That P.S.C. MO No. 2, Original Adoption Notice, denominated as Tariff No. 9900739, filed March 26, 1999, by AquaSource/RU, Inc. is hereby recognized in all Commission records.
2. That this order shall become effective on April 13, 1999.
3. That this case may be closed on April 14, 1999.

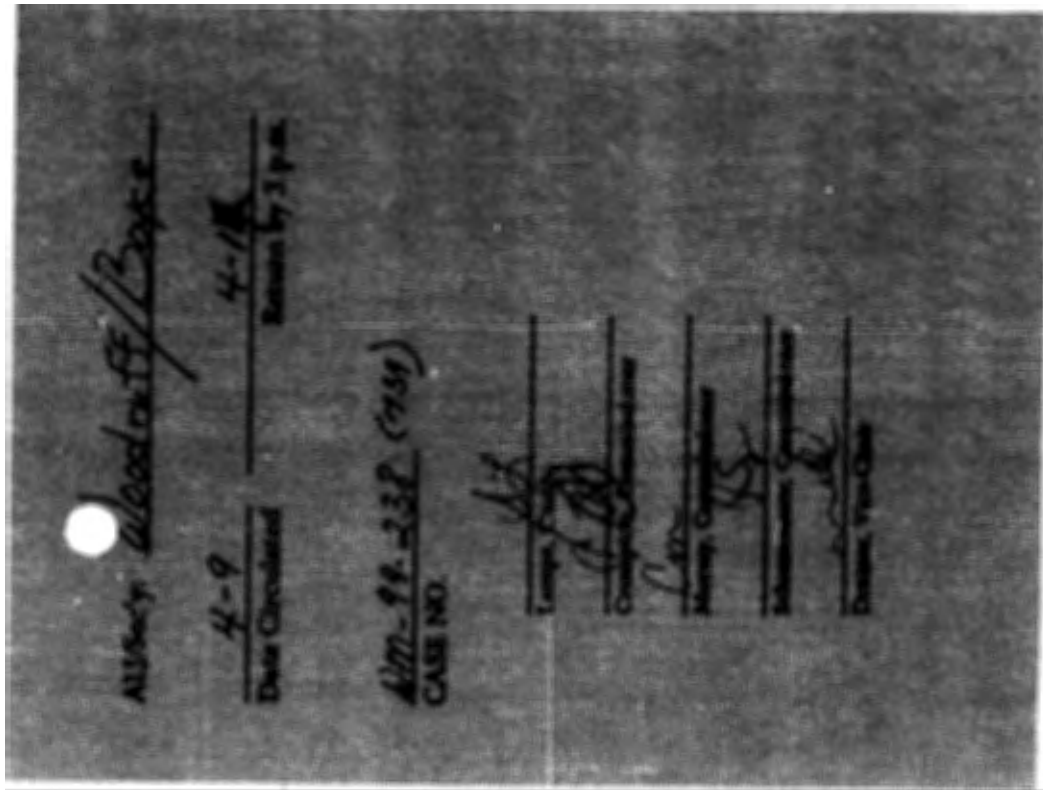
