## MOTION TO OPEN CASE AND CANCEL CERTIFICATES OF SERVICE AUTHORITY

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff) and for its Motion to Open Case and Cancel Certificates of Service Authority to Provide Private Pay Telephone Services, respectfully states:

1. The above captioned individuals (Providers) have been granted certificates of service authority by the Missouri Public Service Commission (Commission) to provide private pay telephone services, pursuant to the Commission's authority under Section 386.250, RSMo 2000. A list containing information for each of the Providers was prepared and verified by affiant

Staff employee Sherri L. Kohly of the Utility Operations Division of the Commission. A copy of said list is marked "Appendix A," attached hereto and made a part hereof.

2. Each of the Providers share the following facts that support Staff's motion to open a mass docket case for the cancellation of the Providers' certificates:

- a) Staff is unable to contact the Providers through a valid mailing address or telephone number.
- b) The Providers' 2003 statement of revenue form, which was mailed by the Budget and Fiscal Services Department of the Commission's Administration Division on January 15, 2004, was returned by the post office as undeliverable.

3. Staff believes that the Providers have violated the terms of their certificates of service authority by 1) their failure to keep the Commission informed of a current address and telephone number, and 2) by the failure of the Providers to file a 2003 statement of revenue. See Affidavit of Sherri Kohly, marked "Appendix B," attached hereto and made a part hereof. Section 392.210(2), RSMo 2000 states, among other things, "The commission shall at all times have access to all accounts, records and memoranda kept by telecommunications companies...." Because the Providers have failed to keep the Commission informed of a current address or telephone number, the Commission is unable to contact the Providers. Therefore, the Providers have denied the Commission the access that is required of the Commission its ability to supervise telecommunications operations and services as statutorily mandated under Section 386.250.

4. Staff has made an investigation and no other matters are pending in front of the Commission.

5. The Commission has the authority to cancel a telecommunications company certificate pursuant to Section 392.410.5, RSMo 2000, which provides:

Any certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.

However, the Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing. *State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public Service Commission*, 776 S.W.2d 494 (Mo. App. 1989).

6. Because the Providers have provided no current contact information and because the 2003 statement of revenue was returned to the Commission by the United States Postal Service as undeliverable, Staff is serving this pleading on the last known principal office address of the Providers. Commission Rule 4 CSR 240-2.080(17)(C)(1) states "Service by mail is complete upon mailing."

WHEREFORE, the Staff recommends the Commission cancel the certificates of service authority to provide private pay telephone service.
