ORDER ON RECONSIDERATION

On July 15, 1988, the Commission issued an Order Granting Rehearing And Reconsideration wherein the Commission agreed to reconsider two regulatory requirements placed on Kansas City Cable Partners (KCCP) when the Commission granted KCCP a certificate of service authority to provide intrastate private line, high-speed telecommunications service. As part of the reconsideration the Commission ordered Commission Staff to review the two regulatory requirements and file a recommendation with the Commission concerning the two requirements. The Commission gave KCCP an opportunity to respond to Staff's recommendation.

On August 16, 1988, Staff filed its recommendation. The recommendation addressed the two regulatory requirements. These requirements are: (1) KCCP is required to file tariffs containing rules and regulations applicable to customers, a description of the service provided and a list of rates associated with the service pursuant to Section 392.220, R.S.Mo. (Supp. 1987), and 4 CSR 240-30.010; and (2) pursuant to Section 392.390(3), R.S.Mo. (Supp. 1987), KCCP is required to comply with the jurisdictional reporting requirements as set out in each local exchange company's access services tariff.

Staff indicates in its recommendation that unless a service has been declared detariffed or deregulated, a company must file specific tariffed rates for its services. Staff points out that the Commission has allowed Southwestern Bell

Telephone Company (SWB) to file a Customer Specific Pricing Plan (CSPP) for customized rates for qualifying private line customers whose current or proposed monthly charges for private line services exceed \$2,000.00. Staff recommends KCCP be authorized to file a CSPP-type tariff under the same terms and conditions as SWB. Staff recommends further that as long as KCCP provides only private line services, KCCP not be required to report its jurisdictional traffic.

KCCP did not file a response to Staff's recommendation.

The Commission has determined that based upon Staff's recommendation it should modify the regulatory requirements for KCCP as set out in paragraphs (2) and (7) of the Report And Order issued June 10, 1988. The Commission has determined that paragraph (2) should be modified to require KCCP to file specific tariffed rates for private line services with current or proposed private line charges of less than \$2,000.00 per month, and to authorize KCCP to file a tariff under the same terms and conditions as SWB's CSPP tariff applicable to current or proposed private line charges of \$2,000.00 per month or more. The Commission has determined paragraph (7) shall be modified to not require KCCP to file jurisdictional reports as long as KCCP only provides private line service.

It is, therefore,

ORDERED: 1. That the regulatory requirements for Kansas City Cable

Partners in paragraph (2) on page 5 of the Report And Order issued June 10, 1988, are

modified as described in this order.

ORDERED: 2. That the regulatory requirements for Kansas City Cable

Partners in paragraph (7) on page 6 of the Report And Order issued June 10, 1988, are

modified as described in this order.

ORDERED: 3. That the certificate of service authority granted Kansas City Cable Partners shall become effective upon approval by the Commission of tariffs to provide service.

ORDERED: 4. That this order shall become effective on September 23, 1988.
