# ORDER APPROVING TARIFF FILED IN COMPLIANCE WITH COMMISSION ORDER AND CLOSING CASE

On February 10, 2000, IDT America, Corp. (IDT or Applicant), filed its application pursuant to Section 392.300, RSMo Supp. 1999, and 4 CSR 240-2.060(5) for approval of a transaction whereby IDT would acquire certain business and residential customers of MCI WorldCom Communications, Inc. The Commission's Staff reviewed the application and provided its recommendation on May 24, 2000. On June 1, 2000, the Commission entered its order approving the proposed transfer of assets. That order required IDT to file tariff amendments to assure that services and terms of services to the affected customers after the transaction would be equal or better to the services and terms of services provided before the transaction.

IDT file its tariff amendments on July 13, 2000, pursuant to the requirements of the Commission's order. The tariff sheets have an effective date of August 12, 2000. On August 3, 2000, the Commission's Staff filed its recommendation that the proposed tariff filing be approved.

Based on the tariff filing and the recommendation of the Staff, the Commission finds that the proposed tariff filing complies with the

Commission's June 1, 2000, order and should be approved. No further action is required in this case and therefore this case may be closed.

#### IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by IDT America, Corp., on July 13, 2000, Tariff File No. 200100035, are approved for service on and after August 12, 2000. The tariff sheets approved are:
