

ORDER AND NOTICE

Spectra Communications Group, LLC (Spectra), filed an application on June 14, 2000, requesting designation as an eligible telecommunications carrier pursuant to Section 254 of the Telecommunications Act of 1996 and Federal Communications Commission regulations 47 CFR 54.201, *et seq.* Spectra states that when its tariffs currently on file with the Commission are approved, it will provide the services supported by federal universal service support and it will advertise the availability of those services. Spectra requests that its designation be ordered to become effective on August 1, 2000, the proposed effective date of its basic local exchange.

The Commission determines that notice and an opportunity to intervene in this matter should be given. The Records Department of the Commission will be ordered to send a copy of this order to all certificated Missouri local exchange and interexchange carriers.


