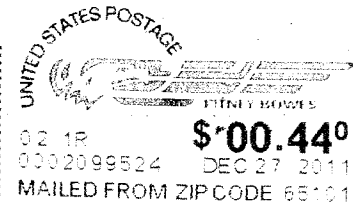

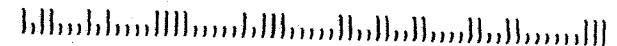

ORDER CANCELING CERTIFICATE

Issue Date: December 23, 2011

Effective Date: December 31, 2011

On December 9, 2011, the Staff of the Missouri Public Service Commission filed a motion requesting Power Station, LLC's certificate of service authority to provide private pay telephone services in the State of Missouri be cancelled.

In File Number PA-2009-0323, the Commission granted Power Station a certificate of service authority to provide private pay telephone service in the State of Missouri.

Staff states in its motion that Power Station requested the Commission cancel their certificate on their most recent Statement of Revenue. Although Power Station is delinquent in its payment of the Fiscal Year 2011 assessment, Staff recommends that the Commission cancel Power Station's certificate of service authority to provide private pay telephone service.

On December 12, 2011, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than December 22, 2011. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Power Station, LLC, shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide private pay telephone services granted to Power Station, LLC, in File Number PA-2009-0323, is canceled.
2. This order shall become effective on December 31, 2011.
3. This case may be closed on January 1, 2012.


