ORDER CANCELING CERTIFICATE

Issue Date: January 18, 2018

Effective Date: February 17, 2018

This order cancels the private pay telephone certificate of Protocall Telecom, LLC ("Protocall").

On December 27, 2017, the Staff of the Missouri Public Service Commission filed a motion requesting Protocall's certificate to provide private pay telephone service in the State of Missouri be canceled.

In File Number PA-2006-0080, the Commission granted Protocall a certificate of service authority to provide private pay telephone service in the State of Missouri via customer-owned coin-operated telephone equipment.

Staff's motion states that on October 19, 2017, the company notified the Commission that it no longer wished to retain its certification to provide private pay telephone services in Missouri.

On December 27, 2017, the Commission issued an Order Establishing Time to Respond to Motion allowing anyone to file a response or request a hearing to do so no later than January 8, 2018. No responses were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo 2016 which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice

and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the private payphone certificate granted to Protocall shall be canceled.

THE COMMISSION ORDERS THAT:

1. The private payphone certificate granted to Protocall Telecom, LLC in File Number PA-2006-0080, is canceled.
2. This order shall become effective on February 17, 2018.
3. This case may be closed on February 18, 2018.
