

**ORDER DIRECTING FILING**

On October 26, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a motion for finding necessity for rule-making. In its status report, filed on October 23, 2000, Staff had promised to file this motion no later than October 27.

The Commission issued its order finding a necessity for rulemaking in this case on June 15, 2000. Staff's motion fails to explain why a second such order is necessary in this case and, consequently, shall be denied. Staff shall file a pleading advising the Commission of a date certain on which the proposed text of the amendment shall be filed.

**IT IS THEREFORE ORDERED:**

1. That the Motion to Find Necessity for Rulemaking, filed by the Staff of the Missouri Public Service Commission on October 26, 2000, is denied.

2. That the Staff of the Missouri Public Service Commission shall file, by November 27, 2000, a pleading which states a date certain by which the Staff shall file herein the proposed text of the amended rule.

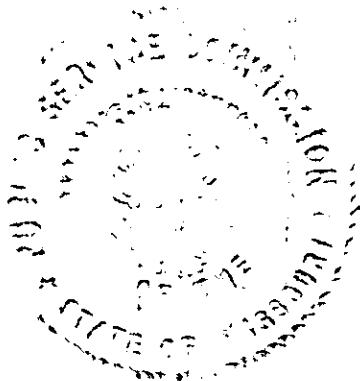
