ORDER APPROVING TARIFFS FILED IN COMPLIANCE WITH COMMISSION DECISION

On January 12, 1999, the Commission issued its Order Approving Stipulation and Agreement granting a certificate of service authority to NEXTLINK MISSOURI, INC. (NEXTLINK) authorizing it to provide basic exchange and local exchange intrastate telecommunications local services in the State of Missouri. NEXTLINK also granted was temporary waiver of 4 CSR 240-2.060(4)(H) which requires the filing of its 45-day tariff with its application. The Commission directed NEXTLINK to submit its tariffs for Commission approval within 30 days of the effective date of an order approving its interconnection agreement.

The Commission approved NEXTLINK's interconnection agreement with Southwestern Bell Telephone Company (SWBT) in Case No. TO-99-270 effective February 23, 1999. NEXTLINK requested and was granted an extension of time to file its proposed tariff sheets until May 11, 1999. On May 11, 1999, NEXTLINK filed the tariff sheets as required with an effective date of June 25, 1999. On June 11, 1999, NEXTLINK

notified the Commission that it wished to extend its effective date to July 16, 1999. Substitute tariff sheets were filed on June 23 and June 28, 1999.

On June 30, 1999, Staff filed a memorandum recommending that the Commission approve the proposed tariff sheets as modified to become effective on July 16, 1999. Staff stated that it had reviewed the tariff sheets and substituted tariff sheets and is of the opinion that the tariff sheets and substitute tariff sheets comply with the Commission's order. Staff also stated that NEXTLINK's proposed tariff covers the provision of resold and facilities-based basic local exchange service. Staff also noted that NEXTLINK's proposed tariff is similar to other CLEC tariffs previously approved by the Commission for basic local exchange service.

The Commission has reviewed NEXTLINK's tariff filing and Staff's memorandum. The Commission finds that the tariff sheets and substitute tariff sheets filed should be approved for service rendered on or after July 16, 1999.

IT IS THEREFORE ORDERED:

1. That Tariff File No. 9900870, submitted in Case No. TA-99-48 by NEXTLINK MISSOURI, INC. is hereby approved for service to be rendered on or after July 16, 1999:

- 3. That this case may be closed after July 16, 1999.
