**PROPOSED LIST OF ISSUES, ORDER OF WITNESSES,
AND ORDER OF CROSS-EXAMINATION**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and states as follows:

1. On September 7, 2000, the Missouri Public Service Commission (Commission) issued an Order Adopting Procedural Schedule which directs, *inter alia*, that "[t]he parties shall agree upon and the Staff shall file a list of the issues to be heard, the witnesses to appear on each day of the hearing and the order in which they shall be called, and the order of cross-examination for each witness. Any issue not contained in this list of issues will be viewed as uncontested and not requiring resolution by the Commission."

2. The Staff and other parties have agreed upon the following list of issues to be heard:

1. Is SWBT properly making Local Plus service available for resale to IXC's and CLECs?

2. Who should be responsible for paying terminating access charges to third-party LECs when:

a. Local Plus is being offered through pure resale of SWBT's retail Local Plus offering?

b. Local Plus is being offered through a facility-based carrier's purchase of unbundled switching from SWBT?

c. Local Plus is being offered through a facility-based carrier's own switch?

3. The parties propose the following order of witnesses and order of cross-examination:
