ORDER APPROVING TARIFF

BroadBand Office Communications, Inc. (BBOC or Applicant), applied to the Commission on December 16, 1999, for a certificate of service authority to provide competitive basic local and local exchange and intrastate interexchange telecommunications services in the state of Missouri pursuant to Sections 392.430, 392.440, RSMo 1994, and 392.450 and 392.451, RSMo Supp. 1999. BBOC requested competitive classification and an order waiving certain Commission rules and statutory provisions pursuant to the federal Telecommunications Act of 1996.

The Commission issued an Order Granting Certificate to Provide Basic Local Exchange, Exchange Access, and Interexchange Telecommunications Services on April 4, 2000. The Commission provided that the certificates would become effective when the Company's tariff became effective. The case was closed on April 17, 2000.

On May 10, 2000, BBOC filed its original P.S.C. Mo. Tariff No. 1 with the Commission. The tariff file number assigned by the Commission is 200001030. The Commission's Staff filed its recommendation regarding the



tariff in this case on July 11, 2000. The filing of the Staff's recommendation reopens this case to consider BBOC's tariff.

The tariff was extended by BBOC on two separate occasions with a final effective date of July 21, 2000. BBOC subsequently extended the effective date of its tariff until June 17, 2000, and later to June 25, 2000. BBOC filed substitute sheets to its tariff on July 7, 2000. Staff recommends that the tariff be approved as amended.

The Commission has reviewed the tariff and Staff's recommendation and finds that the tariff should be approved. Further, the tariff shall become effective on the effective date of this order. BBOC's certificates of service authority shall become effective with the tariff effective date.

IT IS THEREFORE ORDERED:

- 1. That this case is reopened for consideration of the tariff filed by BroadBand Office Communications, Inc.
- 2. That the tariff filed by BroadBand Office Communications, Inc., on May 10, 2000, and assigned tariff number 200001030, is approved as amended to become effective on July 21, 2000. The tariff approved is:

3. That the certificates of service authority to provide basic local exchange telecommunications service and to provide intrastate interexchange telecommunications service in the state of Missouri granted to BroadBand Office Communications, Inc., in the Commission's order dated April 4, 2000, shall become effective on July 21, 2000.

- 4. That this order shall become effective on July 21, 2000.
- 5. That this case may be closed on July 24, 2000.


