

ORDER DIRECTING FILING

On October 19, 1999, the Commission issued its order approving an interconnection agreement between Computer Business Sciences, Inc. (CBSI), and Southwestern Bell Telephone Company. That order included a requirement that CBSI file with the Commission Staff, on or before November 15, 1999, an executed copy of the agreement with the pages numbered seriatim in the lower right-hand corner, and, at the same time, file a notice in the official case file advising the Commission that the agreement has been submitted to Staff as required. CBSI has not yet complied with the Commission's Order.

IT IS THEREFORE ORDERED:

1. That Computer Business Sciences, Inc., shall, within ten (10) days of the effective date of this Order, file an executed copy of its approved interconnection agreement with the Staff of the Missouri Public Service Commission, with the pages numbered seriatim in the lower right-hand corner.

2. That Computer Business Sciences, Inc., shall, within ten (10) days of the effective date of this Order, file a notice in the official

case file advising the Commission that the agreement has been submitted to Staff as required.

3. That this Order shall become effective on November 23, 1999.
