ORDER AND NOTICE

On December 19, 1991, Osage Water Company (Applicant) filed four applications. Applicant is subject to the jurisdiction of this Commission as a "water corporation" as that term is defined in Section 386.025, RSMo 1986.

By a Report and Order issued in Case No. WM-89-73, Applicant was given permission to acquire and operate a water system rendering water service in a portion of Camden County. By the application in Case No. WA-92-141, Applicant seeks an extension of its certificate of public convenience and necessity to include an area including part of the City of Osage Beach, Missouri, all of the Village of Sunrise Beach, Missouri, plus unincorporated portions of Camden and Miller Counties,

Missouri, in an area extending from Wilson Bend on the west to Shawnee Bend and Linn Creek Bend on the east. Simultaneous applications in Case Nos. WM-92-138, WF-92-139 and WF-92-140 seek permission for William Patterson Mitchell, an individual, to acquire the stock of Osage Water Company he does not presently own and for permission to issue additional stock.

The Commission is of the opinion that the four cases should be consolidated and that notice should be given of the consolidated cases and that the Commission's Executive Secretary shall send a copy of this order to the County Commissioners in Camden and Miller Counties and to the municipalities located in the proposed service area. In addition, notice shall be sent to all of the members of the Missouri General Assembly representing the proposed service areas and to the newspapers located in the same area, as listed in the Newspaper Directory of the current Official Manual of the State of Missouri.

The Commission is also of the opinion that an intervention date should be established. If no proper parties intervene and neither Public Counsel nor Staff requests a hearing, the Commission may allow the Applicant to support its application by verified statement.

**IT IS THEREFORE ORDERED:**

1. That persons desiring to intervene in this matter shall file an application to intervene with the Executive Secretary, Missouri Public Service Commission, P. O. Box 360, Jefferson City, Missouri 65102, on or before January 31, 1992, and shall serve a copy on the Osage Water Company's representatives:
