ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

The Commission approved the sale of assets and granted a certificate of public convenience and necessity to Stephen T. Fennema and Mona L. Fennema d/b/a Woodland Manor Water Company (WHWC) 00 February 17, 1999. The order directed WNWC to file an adoption notice to adopt the tariff of Bob Connell d/b/a Woodland Nanor Water Company. WNWC filed the required tariff sheets on March 17, 1999. On March 31, 1999, WNWC filed a substitute sheet to correct a typographical error. A copy of WMMC's Registration of Fictitious Name was filed with the Commission on March 22, 1999.

The February 17, 1999, order stated that the certificate of public convenience and necessity granted to NANNC would become effective simultaneously with the effective date of the tariff adoption notice. The certificate of public convenience and necessity issued to Bob Connell d/b/a Woodland Manor Water Company was also ordered to be canceled on the effective date of the adoption notice.

The Staff of the Missouri Public Service Commission (Staff) reviewed the tariff sheets and filed a memorandum on April 5, 1999,

recommending that the Commission approve the tariff sheets as amended to become effective on April 19, 1999.

The Commission has reviewed the tariffs sheets and the Staff's recommendation and finds that the tariff sheets conform to the Commission's order and should be approved to become effective on April 19, 1999.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by Stephen T. Fennema and Mona L. Fennema d/b/a Woodland Manor Water Company on March 17, 1999, are approved as amended to become effective on April 19, 1999. The tariff sheets approved are:

P.S.C. MD No. 1 Original Sheet No. A 1st Revised Sheet No. 1 canceling Original Sheet No. 1

2. That the certificate of public convenience and necessity previously granted to Stephen T. Fennema and Mona L. Fennema d/b/a Woodland Manor Water Company shall become effective on April 19, 1999.

3. That the certificate of public convenience and necessity issued to Bob Connell d/b/a Woodland Manor Water Company shall be canceled on April 19, 1999.

4. That this order shall become effective on April 19, 1999.
