**ORDER CANCELING CERTIFICATES**

Issue Date: December 28, 2005

Effective Date: January 7, 2006

On December 13, 2005, the Staff of the Commission filed a Motion to Open Case and Cancel Certificates of Service Authority. Staff requested that the Commission cancel the private pay telephone certificates of service authority of the above-mentioned providers.

Staff stated that these providers are no longer entitled to their certificates because each provider failed to submit a Statement of Revenue for Fiscal Year 2006. Furthermore, Staff stated that it assessed all of the above providers with an estimated assessment of \$0.00, and alleges that each provider owes no assessments.

Commission Rule 4 CSR 240-2.080(15) gives parties 10 days to respond to pleadings. Each provider failed to respond within 10 days.

Section 392.410, RSMo 2000, gives the Commission authority over granting certificates of service authority to provide telecommunications services. The Commission has reviewed Staff's motion and finds that it should cancel the certificates of service authority that Staff requested the Commission to cancel.

**IT IS THEREFORE ORDERED:**

1. That the Staff of the Commission's Motion to Open Case and Cancel Certificates of Service Authority is granted.

2. That the private pay telephone certificate of service authority granted to Harold B. Flora d/b/a American Telephone Service in Case No. TA-91-207 is canceled.

3. That the private pay telephone certificate of service authority granted to Timothy W. Sander d/b/a Independent Telecom in Case No. TA-94-282 is canceled.

4. That the private pay telephone certificate of service authority granted to Jerry Guelker in Case No. TA-92-161 is canceled.

5. That the private pay telephone certificate of service authority granted to Johnny J. Stimage in Case No. TA-99-612 is canceled.

6. That the private pay telephone certificate of service authority granted to Joseph Denatale in Case No. TA-96-318 is canceled.

7. That the private pay telephone certificate of service authority granted to Kenneth Arthur in Case No. TA-2001-337 is canceled.

8. That the private pay telephone certificate of service authority granted to Larry Crow d/b/a L&L Telecom in Case No. TA-96-416 is canceled.

9. That the private pay telephone certificate of service authority granted to Larry A. Fiscus in Case No. TA-99-356 is canceled.

10. That the private pay telephone certificate of service authority granted to Linda R. Leach in Case No. TA-96-146 is canceled.

11. That the private pay telephone certificate of service authority granted to Mark A. Hunter in Case No. TA-94-257 is canceled.

12. That the private pay telephone certificate of service authority granted to Mark L. Conlee in Case No. TA-92-247 is canceled.

13. That the private pay telephone certificate of service authority granted to Douglas C. Marshall d/b/a Mi Familia Distributing in Case No. TA-97-373 is canceled.

14. That the private pay telephone certificate of service authority granted to Michael V. Merx in Case No. TA-95-11 is canceled.

15. That the private pay telephone certificate of service authority granted to Mark B. Langworthy d/b/a Midwest Telephone in Case No. TA-2000-45 is canceled.

16. That the private pay telephone certificate of service authority granted to Mojtaba M. Jadjiha in Case No. TA-2003-0309 is canceled.

17. That the private pay telephone certificate of service authority granted to Pat Whiteaker in Case No. TA-93-168 is canceled.
