**ORDER DIRECTING FILING**

On April 20, 1999, CCCMO, Inc., doing business as Connect! (Applicant or Connect!) filed an application with the Commission seeking approval of an interconnection agreement with Southwestern Bell Telephone Company (SWBT) under the provisions of the federal Telecommunications Act of 1996 (the Act).

The application filed by Connect! was deficient in certain respects. Rule 4 CSR 240-2.060(1)(A) requires that every application set out the legal name of the applicant and provide proof that the applicant's fictitious name, if any, is registered with the Missouri Secretary of State. Rule 4 CSR 240-2.060(1)(F), in turn, requires that every application be verified by affidavit under oath. The declaration of Connect!'s attorney, contained in Connect!'s application at paragraph seven, does not satisfy this requirement.

On April 29, 1999, the Commission by order pointed out these deficiencies to Connect! and directed that they be corrected on or before May 21, 1999. On May 19, 1999, Connect! filed a letter which stated that it was accompanied by an amended application. However, no amended application was ever actually filed, either with the cover

letter or otherwise. Therefore, the Commission shall offer one more chance to Connect! to correct the deficiencies in it's application. Should Connect! fail a second time to correct these deficiencies, this case shall be dismissed without further notice.

**IT IS THEREFORE ORDERED:**

1. That CCCMO, Inc., doing business as Connect!, shall, within ten (10) days of the effective date of this Order, supplement its application by filing a verification of the same by affidavit under oath and proof of the registration of its fictitious name with the Missouri Secretary of State.

2. That this order shall become effective on June 3, 1999.
