ORDER GRANTING DEPARTMENT OF CONSERVATION'S REQUEST TO EXTEND TIME TO DEPOSE WITNESSES

Issue Date: September 24, 2018 Effective Date: September 24, 2018

The procedural schedule established for this case provides that the last day that a deposition may be taken is October 12, 2018. The Missouri Department of Conservation filed a motion on September 21 asking that the procedural schedule be modified to extend the last day to take a deposition to October 19.

The motion explains that because of significant scheduling difficulties, the Department of Conservation would like to depose an Ameren Missouri witness as late as October 19. The motion represents that Ameren Missouri has agreed to extend the deposition date in that manner, and indicates counsel for the other parties do not object to that extension.

The Department of Conservation's motion could be interpreted as requesting a one-week extension of the deposition deadline for all parties, for all purposes. Such broad relief is not warranted. Instead, the Commission will grant the request more narrowly to just extend the time allowed for the Department of Conservation to depose Ameren Missouri witnesses. If any other party believes it too should be allowed more time to depose a witness, it may file its own request for extension.

THE COMMISSION ORDERS THAT:

- The Missouri Department of Conservation is granted a variance from the established procedural schedule to allow it until October 19, 2018 to depose Ameren Missouri witnesses.
 - 2. No other aspect of the procedural schedule is modified.
 - 3. This order shall be effective when issued.
