ORDER RESCHEDULING PREHEARING CONFERENCE

On October 6, 1998, the Commission issued an order scheduling a prehearing conference (attached hereto as Exhibit A). That order was not served on all the parties to Case No. EM-96-149, who were made parties to this case by Commission order on June 18. Since all parties have not been notified of the prehearing conference, it will be rescheduled to allow parties sufficient notice. The deadline for filing a proposed procedural schedule will also be rescheduled.

IT IS THEREFORE ORDERED:

1. That the prehearing conference scheduled for October 15, 1998, at 9:00 a.m. will be rescheduled to October 23, 1998 at 9:00 a.m. at the Commission's offices on the fifth floor of the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri.

2. ORDER SCHEDULING PREHEARING CONFERENCE

On March 30, 1998, Union Electric Company d/b/a AmerenUE (AmerenUE) filed an application (Missouri Application) requesting Commission authority to participate in the Midwest Independent Transmission System Operator, Inc. (MISO). On July 22, the Commission Staff (Staff) and the Office of the Public Counsel (Public Counsel) filed responses pursuant to a Commission order in which they recommend that the Commission not rule on AmerenUE's Missouri Application until the Federal Energy Regulatory Commission rules on the MISO application before it (FERC Application). On August 24, a group of AmerenUE's industrial customers¹ filed a response in which they also request that the Commission defer action on the Missouri Application until the FERC acts on the FERC Application. Finally, on September 4, AmerenUE filed a response to the other three parties in which it agreed that the Commission should defer action on the Missouri Application until the FERC acts on the FERC

Application, although it disagreed with the other parties' characterization of the FERC Application.

On September 16, FERC issued an order conditionally approving the FERC Application. Accordingly, it appears that this case is ready to proceed, and the Commission will direct the parties to meet at a prehearing conference and propose a procedural schedule.

IT IS THEREFORE ORDERED:

1. That a prehearing conference will be held on October 15, 1998, at 9:00 a.m. at the Commission's offices on the fifth floor of the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri.

2.
