ORDER APPROVING TARIFF

to the Commission's informal rate procedure, September 22, 1997, Four Seasons Water & Sewer Company (Four Seasons or Company) filed a tariff designed to increase its rate for sewer service by 100 percent. On October 29, Four Seasons filed a letter with Staff requesting that the schedule for the informal rate procedure be extended to accommodate the completed construction of an expansion at its Racquet Club wastewater treatment plant. On June 18, 1998, the Company filed a letter with its revised tariff sheets, an Agreement Regarding Disposition of Small Company Rate Increase Request and a copy of the proposed depreciation rates for sewer service at Four Seasons Water & Sewer Company.

On July 21, 1998, a recommendation was filed by the Staff of the Commission (Staff) reflecting agreement between the Staff and the Company regarding the proposed rate increase in the Company's tariff filed June 18. In its memorandum, Staff stated it reviewed the September 22, 1997 filing and in April 1998, the Staff concluded that the Company could justify an increase of \$115,103 in its Horseshoe Bend sewer system annual

operating revenues. After communications and negotiations with the Company, the Staff modified its proposed Horseshoe Bend sewer service annual operating revenue increase to \$119,408. Based on Staff's calculations, this increase is approximately 84 percent of the Company's annual operating revenues.

On June 11, the Office of the Public Counsel (OPC) advised Staff that OPC was not willing, at that time, to agree to the latest Staff recommendation. OPC requested that a second notice to sewer customers be sent due to an increase in the proposed residential rate from that which was requested by the sewer company. It should be noted that the Company originally requested a flat rate residential charge of \$22.92 and a commercial rate of \$.87 per 1,000 gallon base charge and \$1.74 per 1000 gallon usage charge. Staff recommended a flat residential rate of Further, Staff recommended a commercial rate of \$.55 for a \$25.54. monthly base charge per 1,000 gallons and a monthly usage charge of \$3.57 per 1,000 gallons. A second notice was sent to customers on June 18, 1998. Following both the initial customer notice issued on October 10, 1997 and the second customer notice issued on June 18, 1998, no customer response was received by either the Staff or the OPC.

On July 15, OPC joined Four Seasons and Staff in the Agreement Regarding Disposition of Small Company Rate Increase Request in a letter filed with Staff by John B. Coffman, Deputy Public Counsel. In its July 20 Memorandum, Staff recommends that the Commission issue an order approving the tariff sheet, filed June 18, 1998, by Four Seasons for the Company's Horseshoe Bend service area for service rendered on or after August 2:

Staff further recommends that the Commission's order in this case include approval of the depreciation rates for sewer service as set out on Attachment F of its Memorandum (attached.)

The Commission finds the proposed tariff sheet, as submitted on June 18, to be reasonable and justified. The Commission will adopt the proposed tariff for service on or after August 2.

IT IS THEREFORE ORDERED:

 That the following tariff sheet, filed June 18, 1998, by Four Seasons Water & Sewer Company, is approved for service on or after August 2, 1998:

- 2. That this order shall become effective on August 2, 1998.
- 3. That this case may be closed after August 3, 1998.
