Intervenors state that Sprint is a local exchange carrier authorized to provide local exchange, private line, access and toll services within the State of Missouri, including two exchanges involved in MCA service. Some of Sprint's customers are subscribers to MCA service. Thus, Intervenors claim that this case may impact the provisioning and availability of MCA service to persons called by Sprint customers. In addition, this case may impact Sprint's payment or receipt of intercompany compensation. Consequently, Sprint argues that it has a direct interest in this matter that is different than that of the general public.

In addition, Intervenorors state that they have challenged¹ the assignment of NXX codes to PCS which are currently being used by PCS end user customers. Any modification to the MCA service associated with these NXX codes will impact PCS and its end user customers. Consequently, PCS argues that it has a direct interest in this matter that is different from that of the general public.

The Commission has examined the pleadings and found that there is the showing as required by 4 CSR 240-2.075 that the Intervenorors have an interest in the proceeding which is different from that of the general public.

IT IS THEREFORE ORDERED:

1. That Sprint Missouri Inc. d/b/a Sprint and Sprint Spectrum LP d/b/a Sprint PCS are granted intervention.
2. That this order shall be effective on April 22, 1999.
