ORDER APPROVING TARIFFS

On August 12, 1992, Union Electric Company (UE) filed tariff sheets pursuant to the Report and Order issued by the Commission in this case on July 31, 1992. On August 20, 1992, the Staff of the Commission (Staff) filed a memorandum recommending that the Commission approve the tariff sheets for service on and after September 1, 1992.

Based on the Staff's recommendation, the Commission finds that UE's proposed tariff sheets are in compliance with the Commission's Report and Order of July 31, 1992.
