- 4. At present Wasatch believes it met the Commission's request to gain adequate representation and has met regulatory requirements to request a change of electric supplier from Union Electric Company, d/b/a AmerenUE, to Cuivre River Electric Cooperative Inc.(Cuivre).

- 5. The Staff Recommendation dated September 14, 2007 contains an error on page
 - 2. At no time has Cuivre supplied or provided any service to Wasatch, at the subject property.
- 6. Wasatch agrees with Staff that Cuivre is not qualified to provide service within the city limits of O'Fallon, Missouri due to the property not falling under the classification of "rural Area" as defined by §394.020(3) RSMo. 2000.
- 7. Wasatch agrees with Staff that a territorial agreement between Cuivre River,

 AmerenUE and the City of O'Fallon can be obtained through §394.315.2, RSMo
 2000.

WHEREFORE Wasatch respectfully requests that the Commission Grant Wasatch's Application for Change of Electric Service Provider.
