**ORDER APPROVING TARIFFS**

On November 9, 2000, the Commission granted certificates of service authority to provide basic local and local exchange telecommunications services to Teligent Services, Inc. (TSI). The Commission also approved the parties' Unanimous Stipulation and Agreement filed on October 4, 2000. In the Unanimous Stipulation and Agreement, the parties agreed that the Staff of the Missouri Public Service Commission (Staff) would separately evaluate the proposed tariff sheets submitted with the application for certification and render its recommendation. The Commission ordered in its November 9, 2000 order that TSI's certificate of service authority will become effective upon the effective date of its approved tariffs. The Commission approved an interconnection agreement between TSI and Southwestern Bell Telephone Company (SWBT) in Case No. TO-99-299 on April 5, 1999.

TSI's proposed tariffs were filed on March 17, 2000, along with the application for certificate of service authority with an effective date of May 1, 2000. Substitute pages were filed with the Commission

on July 3, 2000, August 9, 2000, September 8, 2000, November 13, 2000, November 15, 2000, and November 17, 2000. On November 17, 2000, TSI requested the extension of its effective date to December 5, 2000.

Staff reviewed the proposed tariff sheets and filed its memorandum on November 21, 2000, recommending that the Commission approve the proposed tariffs, as amended. Staff stated that TSI proposes to provide resold and facilities-based basic local telecommunications services to business customers only. Staff stated that customers of TSI will be able to place or receive calls to any calling station in the local calling area, access basic and/or enhanced 911 emergency service, and place or receive calls to 800 telephone numbers. Staff also stated that other services proposed include custom calling services such as Call Waiting and Custom Local Area Signaling Services (CLASS) such as Caller Identification. Staff noted that TSI's proposed exchange access services rates are no higher than those of SWBT, in whose area they propose to operate.

Staff stated that it has reviewed TSI's tariffs, as amended, and finds them acceptable. Staff stated that it has no objections to TSI's proposed tariffs and recommended that the Commission approve tariff P.S.C. Mo. No. 2 and No. 3, with an effective date of December 5, 2000.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the proposed tariff sheets, as amended, should be approved to become effective on December 5, 2000.

**IT IS THEREFORE ORDERED:**

1. That the tariffs, tariff file Nos. 200000843 and 200000852, submitted in Case No. TA-2000-578, by Teligent Services, Inc. on March 17, 2000, are approved as amended to become effective on December 5, 2000. The tariffs approved are:
