APPLICATION OF GTE MIDWEST INCORPORATED AND GTE ARKANSAS INCORPORATED FOR APPROVAL OF INTERCONNECTION AGREEMENT

COMES NOW, GTE Midwest Incorporated ("GTE Midwest") and GTE Arkansas Incorporated ("GTE AR") (collectively, "GTE" or "Applicants") and file this Application for Approval of an Interconnection Agreement (the "Agreement") between GTE and TeleCorp Communications, Inc. ("TeleCorp"), pursuant to Section 252(e) of the Telecommunications Act of 1996 ("the Federal Act") and would respectfully show the Missouri Public Service Commission (the "Commission") the following:

I. THE APPLICANTS

GTE Midwest and GTE AR are engaged in the business of providing local, access, toll and other telecommunications services. The principal office of GTE Midwest and GTE AR is 601 Monroe Street, Suite 304, Jefferson City, Missouri 65101.

II. INTERCONNECTION AGREEMENT REACHED

GTE presents to this Commission for approval an agreement negotiated and executed pursuant to the terms of the Federal Act (Agreement, Attachment 1). After weeks of intensive good faith negotiations to address all of the complex issues involved

in such an agreement, the parties have executed the Interconnection Agreement between GTE and TeleCorp on February 14, 2000, and filed herewith, together with the one (1) appendix incorporated therein.

IV. REQUEST FOR APPROVAL

GTE seeks the Commission's approval of the Agreement, consistent with the provisions of the Federal Act. GTE believes that the implementation of this Agreement complies fully with Section 252(e) of the Federal Act because the Agreement is consistent with the public interest, convenience and necessity and does not discriminate against any telecommunications carrier. The Agreement promotes diversity in providers, provides interconnectivity, and increases customer choices for telecommunications services.

GTE respectfully requests that the Commission grant expeditious approval of this Agreement, without change, suspension or other delay in its implementation. This is a bilateral agreement, reached as a result of negotiations and compromise between

competitors, and the parties do not believe a docket or intervention by other parties is necessary or appropriate.

V. STANDARD FOR REVIEW

The statutory standards of review are set forth in Section 252(e) of the Federal Act which provides as follows:

Section 252(e) of the Federal Act:

- (e) APPROVAL BY STATE COMMISSION
 - (1) APPROVAL REQUIRED. Any interconnection agreement adopted by negotiation or arbitration shall be submitted for approval to the state commission. A state commission to which an agreement is submitted to shall approve or reject the agreement, with written findings as to any deficiencies.
 - (2) GROUNDS FOR REJECTION. The State Commission may only reject -
 - (A) an agreement (or any portion thereof) adopted by negotiation under subsection (a) if it finds that -
 - (i) the agreement (or portion thereof) discriminates against a telecommunications carrier not a party to the agreement; or
 - (ii) the implementation of such agreement or portion is not consistent with the public interest, convenience, and necessity; or

VI. MISSOURI LEGISLATION

The negotiated and executed Agreement is consistent with the Missouri Legislation, Senate Bill No. 507, which became effective on August 28,1996.

VII. CONCLUSION

For the reasons set forth above, GTE respectfully prays that the Commission approve the Agreement expeditiously.
