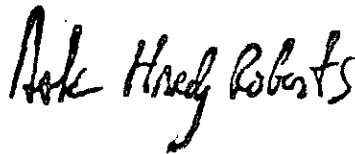

**ORDER RECLASSIFYING RECORDS
AND CLOSING CASE**

On July 12, 2001, the Missouri Public Service Commission issued its Order Approving Stipulation and Agreement. Prior to finally closing this case, the Commission desires to examine and reclassify as public as many of the confidential documents contained in the record which can be appropriately so classified. Therefore, the Commission on July 27, convened a prehearing conference in order to determine how best to proceed. On August 6, Kansas City Power & Light Company filed its Notice of Filing, advising the Commission that the parties agree that all documents of record, with two specific exceptions, may now be reclassified as public records.

Therefore, the Commission will direct the Records Department to reclassify the documents contained in the record of this matter, and will close this case.

IT IS THEREFORE ORDERED:

1. That the Commission's Records Department shall reclassify as public records all of the documents designated "Highly Confidential (HC)" or "Proprietary (P)" contained in the record of this matter, except that Attachments 1 and 2, attached to the

Stipulation and Agreement dated March 28, 2001, and entitled "KCPL 2001 Burner Management System Testing Schedule" and "KCPL 2002 Burner Management System Testing Schedule," respectively, shall continue to be designated "Highly Confidential (HC)" and shall continue to be protected from public disclosure under the Protective Order.

2. That this order shall become effective on August 24, 2001.
3. That this case may be closed on August 25, 2001.
