APPLICATION FOR CHANGE OF ELECTRIC SERVICE PROVIDER

1. Applicant's (Missouri Highways and Transportation Commission, acting by and through the Missouri Department of Transportation) address is: 105 W. Capitol Ave. P.O. Box 270 Jefferson City, MO 65102.

2. The name of Applicant's current electric service provider is: Ozark Electric Cooperative, Inc. James River District Office P.O. Box 1050, Hwy AA Nixa, MO 65714.

3. Applicant requests the Missouri Public Service Commission to order a change of electric supplier to the westbound ramp signal light on the north side of the interchange at Interstate 44 and US 160.

4. Applicant requests the Commission to order a change of electric supplier from Ozark Electric Cooperative, Inc. (Current) to City Utilities of Springfield (Requested).

5. Applicant requests the Missouri Public Service Commission to order a change of electric provider for the following reasons. Applicant is replacing the bridge and upgrading the ramps at the interchange of Interstate 44 at US 160. As part of the ramp upgrade Applicant is installing a signal at the eastbound ramp and upgrading the temporary span wire signals to a permanent metal post and mast arm signal at the westbound ramp. Currently City Utilities of Springfield provides power to the interchange lighting on the south side of the interchange, with Ozark Electric Cooperative

providing power to the north side. As part of the signal upgrade Applicant is proposing to use a single power source to power both signals. This change will allow Applicant to consolidate service with City Utilities of Springfield.

6. Applicant has taken the following steps in an attempt to work out electric service problems with the electric service provider: Applicant has worked with Ozark Electric Cooperative, Inc. and the attached letter indicates that: "Ozark Electric is not opposed to the request and will retire said service when approved by the PSC."

WHEREFORE, Applicant requests the Missouri Public Service Commission to issue an Order which changes the current electric service provider.

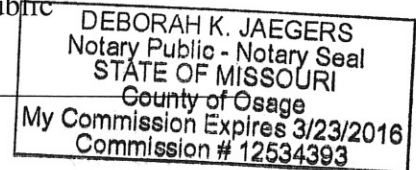
