## SECOND ORDER DIRECTING FILING

On March 22, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a motion to open a case to consider the necessity of amending 4 CSR 240+120.100 to clarify the requirements to which new manufactured homes are to be set up or installed. On April 11, 2000, Staff filed its Motion for Finding of Necessity for Rulemaking with a memorandum attached in support of its motion. The Commission issued an Order Directing Filing on May 31, 2000, which indicated that neither the motion to open case nor the motion for finding of necessity referenced the statute that granted the rulemaking authority. In response, Staff filed an amended motion for finding of necessity for rulemaking on June 1, 2000.

On June 15, 2000, the Commission issued an Order Finding Necessity for Rulemaking. The Commission authorized the Staff to file a proposed amendment in this case for the Commission's consideration. To date, there have been no further filings in this case. The Commission directs Staff to file a status update informing the Commission of whether it anticipates filing a proposed amendment.

#### IT IS THEREFORE ORDERED:

1. That the Staff of the Missouri Public Service Commission shall file, no later than October 23, 2000, a status report detailing

the progress of this case and informing the Commission of when it anticipates filing its next pleading.

2. That this order shall become effective on October 13, 2000.
