ORDER APPROVING TARIFF

On August 5, 1993, International Telecharge, Inc. (ITI) submitted a tariff to reflect that ITI will now be operating under the fictitious name Oncor Communications, Inc. (Oncor or Applicant) and it will also add an operator dialed surcharge and make various other text revisions to its current tariff. ITI also submitted a copy of its Registration of Fictitious Name with the Missouri Secretary of State which was filed with the Secretary of State's Office on June 23, 1993.

The Commission Staff (Staff) filed a recommendation on August 27, 1993 in which the Staff recommended that the Commission approve Applicant's tariff and in which Staff noted that the proposed \$.50 surcharge would be in addition to other applicable operator assistance charges. The surcharge would not apply to calls which cannot be completed by the customer due to equipment failure or trouble on the ITI network, calls made using the calling card, calls made from a payphone, or calls in which an ITI operator places a call for a calling party who identifies himself or herself as being handicapped or unable to dial the call because of his or her handicap. The Staff further noted that other interexchange carriers charge operator dialed surcharges at rates similar to the rate Oncor is proposing. Staff has also noted that at its request Oncor submitted a substitute page to the tariff on August 23, 1993. Based upon this information, the Staff recommended that the Commission approve the Applicant's tariff.

Having considered the Applicant's tariff and the Staff's recommendation, the Commission finds that the proposed tariff details services, equipment and pricing offered to all potential customers, and that the tariff is similar to the approved tariff for other Missouri certificated interexchange carriers that provide similar services. The Commission has also found that the tariff sheets filed by Applicant on August 5, 1993 and as substituted on August 23, 1993 comply with the Commission's guidelines and should be approved for service on and after September 6, 1993.

**IT IS THEREFORE ORDERED:**

1. That the tariff sheets submitted by International Telecharge, Inc. dba Oncor Communications, Inc. on August 5, 1993 and as substituted on August 23, 1993 are hereby approved for service on and after September 6, 1993:


