ORDER GRANTING REQUEST TO EXTEND THE FILING DATE FOR ANNUAL REPORT

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On May 5, 2000, Communicate Technological Systems, Inc. (Communicate), filed a request to extend the filing date for its 1999 annual report. Communicate notes that it originally filed its annual report on April 17, 2000. Communicate states that it recently restructured its electronic database and the conversion of information necessary took longer than originally thought. Due to this delay, the completion of the annual report was delayed.

The Commission finds that good cause exists to permit Communicate to file its annual report out of time, and the Commission will grant the company's request to extend the filing date for the annual report.
