ORDER DIRECTING FILING

On July 15, 1999, Computer Business Sciences, Inc. (CBS), filed its application for certificates of service authority to provide intrastate interexchange and facilities-based basic local telecommunications services to the public. Regulation 4 CSR 240-2.060(1)(F) requires that all applications "be verified by affidavit under oath[.]" CBS's application is not verified. CBS must supplement its application by filing a verification thereof.

CBS's application also lists the following among the statutes and regulations to be waived: §§ 92.210.2, 92.270, 92.280, 92.290.1, 92.300.2. Chapter 92, RSMo, pertains to taxation in St. Louis, Kansas City and certain other cities. The Commission is not authorized to waive any provisions of Chapter 92.¹ CBS must amend its application to correctly designate the provisions whose waiver is sought.

¹Presumably, CBS intended to request waiver of similarly-numbered sections contained in Chapter 392, pertaining to Telecommunications.

IT IS THEREFORE ORDERED:

1. That Computer Business Sciences, Inc., shall, within ten (10) days of the effective date of this Order, file a supplement to its Application containing a verification thereof as required by Commission Rule 4 CSR 240-2.060(1)(F).

2. That Computer Business Sciences, Inc., shall, within ten (10) days of the effective date of this Order, amend its Application to correctly identify the provisions whose waiver is sought.

3. That this Order shall become effective on July 26, 1999.


