ORDER GRANTING APPLICATION TO AMEND AND EXPAND ETC DESIGNATION

Issue Date: July 6, 2011 Effective Date: July 16, 2011

The Missouri Public Service Commission is granting the application to amend the designation ("application") of YourTel America, Inc. ("YourTel") as an eligible telecommunications carrier ("ETC"), and waives regulations related to ETC application content, as follows.

On May 17, 2011, YourTel filed the verified application. On May 18, 2011, the Commission ordered notice to all Missouri-certified telecommunications providers and set a deadline for intervention. The Commission received no application for intervention. On May 23, 2011, the Commission granted YourTel temporary authority to provide service in Joplin, Missouri. On June 27, 2011, Staff filed its verified recommendation.

The Commission has jurisdiction to decide the application.² No law requires a hearing to grant the unopposed application, and no party has sought one,³ so this action does not constitute a contested case,⁴ and the Commission need not separately state its findings of fact. The Commission bases its findings on the verified filings.

In the application, YourTel asks for a waiver of provisions related to high-cost support because YourTel does not, and will not, participate in any high-cost support program. That fact constitutes good cause to waive the high-cost service provisions, as the Commission's regulations provide, ⁵ and Staff agrees that the Commission should waive the high-cost support provisions. Therefore, the Commission will waive those provisions.

In the application, YourTel seeks to expand the areas in which YourTel provides federal Universal Service Fund ("USF") support for low-income wireless telecommunication services ("wireless service") through the Lifeline and Link-Up programs. In its recommendation, Staff states that YourTel qualifies to provide services in the 43 areas proposed in the application at Exhibit A and recommends granting the application.

THE COMMISSION ORDERS THAT:

- 1. The application is granted.
- 2. Commission regulations 4 CSR 240-3.570(4) and 4 CSR 240-3.570(2)(A)1, 2, and 3, are waived.
- 3. The wireless electronic telecommunications carrier designation of YourTel America, Inc., is amended and expanded to include benefits under the Lifeline and Link-Up

programs in the service areas of incumbent local exchange carriers listed in the application at Exhibit A and in the appendix to this order.
