On August 8, 2016, Union Electric Company d/b/a Ameren Missouri; the Office of the Public Counsel; the Commission's Staff; Brightergy, LLC; United for Missouri, Inc.; and the Missouri Department of Economic Development – Division of Energy (collectively, "Movants") filed a *Joint Motion to Modify Procedural Schedule*.
