ORDER GRANTING INTERVENTION AND DIRECTING FILING

On October 12, 2001, Southwestern Bell Telephone Company, Southwestern Bell Texas, Inc., and Southwestern Bell Telephone L.P. d/b/a Southwestern Bell Telephone Company filed a pleading requesting that the Commission approve a corporate restructuring and stock transfer. On October 29, the Small Telephone Company Group¹ filed an application to intervene, a response, and a request for hearing. The Missouri Independent Telephone Company Group,² also on October 29, filed a similar pleading.

Both groups have complied with the Commission's rule on intervention, and both will be granted intervention.

Also on October 29, the Staff of the Commission and the Office of the Public Counsel filed responsive pleadings. Public Counsel, like the STCG and the MITG, requests a hearing. All three responses raise many of the same points. They question what would happen to the status of the charter under which Southwestern Bell (the Missouri corporation) operates if the corporation ceases to exist. Public Counsel raises similar questions about the status of price cap regulation. The STCG suggests that Bell (the limited partnership) might need to apply for a certificate of service authority.

On November 8, Bell filed a reply to these responses. On November 15, Staff filed its recommendation in which it recommended the Commission approve the application. No responses to these pleadings were filed.

The application and the responses raise a number of question, not all of which have been fully addressed by all parties. The Commission will therefore direct the parties to file briefs. The briefs shall address all the issues raised by the application and the responses (and any other issues relevant to the Commission's determination). The parties shall also address the following questions:

 If Southwestern Bell is allowed to reorganize as a Texas limited partnership, will the Commission's oversight over it be any different than if it had remained a Missouri corporation (the parties should pay particular attention to the Commission's oversight over future transfers of property)?

- If Southwestern Bell is allowed to reorganize as a Texas limited partnership, what will become of the franchise and charter granted to the Missouri corporation?
- What questions of fact (distinct from legal questions) are likely to be in dispute and require a hearing for resolution?

IT IS THEREFORE ORDERED:

- 1. That the Small Telephone Company Group is granted intervention.
- 2. That the Missouri Independent Telephone Company Group is granted intervention.
- 3. That the parties shall file briefs as discussed herein no later than December 10, 2001, at 12:00 P.M.
 - 4. That this order shall become effective on December 7, 2001.
