On February 6, 2001, Kansas City Power & Light Company (KCPL) filed a motion seeking leave from the Commission to dismiss its application to restructure itself into a holding company, competitive generation company, regulated utility company and unregulated subsidiary. 4 CSR 240-2.116(1) provides that once prepared testimony has been filed, an applicant may dismiss its action only by leave of the Commission, or by written consent of the adverse parties. No party has filed any objection to KCPL's motion. The Commission will permit KCPL to dismiss its action

3. That this order shall become effective on March 4, 2001.

4. That this case may be closed on March 5, 2001.
