**COMPLAINANT METROPOLITAN ST. LOUIS SEWER DISTRICT'S
STATEMENT IN RESPONSE TO THE COMMISSION'S FEBRUARY 26, 2007 NOTICE**

In accordance with the Notice Regarding Hearing and Order Directing Filing, issued by the Public Service Commission (the "Commission") on February 26, 2007, Complainant Metropolitan St. Louis Sewer District ("MSD") states that the facts set forth in the parties' Joint Statement of Facts, filed on February 14, 2007, are undisputed and that there are no additional facts in dispute in this case.

However, it is MSD's position that many of the facts set forth in the parties' Joint Statement of Facts are not relevant or material to the sole dispute between the parties in this proceeding—whether pursuant to Section 249.645, RSMo, Respondent Missouri-American Water Company ("MAWC") is required to provide certain water usage and customer information data to MSD or otherwise make such information available to MSD free of charge.

Accordingly, MSD believes that an evidentiary hearing is unnecessary and requests that the March 7, 2007 hearing be limited to oral argument on MSD's Motion for Summary Determination, filed December 15, 2006.


