

1. We are duly authorized to execute this document and cause it to be filed with the Missouri Public Service Commission (Commission);
2. We are aware that the Commission approved a Water Service Area Territorial Agreement (Territorial Agreement) filed by the City of Hannibal Missouri and Public Water Supply District No. 1 of Ralls County, Missouri, in Case No. WO-2005-0127 (Report and Order issued January 7, 2005);
3. Under the provisions of that Territorial Agreement, we are aware that the City of Hannibal, Missouri, is exclusively authorized to provide water service to our property located at the address listed above;
4. Notwithstanding the provisions of the Territorial Agreement, we have requested that water service be provided to us at the address listed above by Public Water Supply District No. 1 of Ralls County, Missouri, and we recognize that this represents an exception to the territorial boundaries approved by the Commission in Case No. WO-2005-0127;
5. It is our understanding that both the City of Hannibal, Missouri, and Public Water Supply District No. 1 of Ralls County, Missouri, have consented to our request to be served by Public Water Supply District No. 1 of Ralls County, Missouri, and we have received notice of the contemplated service to be provided;

6. We understand that the Territorial Agreement approved by the Commission permits case-by-case exceptions to that Agreement by filing of an Addendum, pursuant to the terms of paragraph 6 of the Territorial Agreement;

7. We hereby consent to our property being provided water service by Public Water Supply District No. 1 of Ralls County, Missouri, and request that the Missouri Public Service Commission approve the Addendum to the water service territorial agreement filed concurrently herewith to effectuate our request.


