STAFF RECOMMENDATION TO APPROVE TARIFF

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its recommendation that the Commission approve the tariff sheets filed by Timber Creek Sewer Company (“Timber Creek”) states the following:

1. On July 27, 2022, the Commission issued its *Order Granting Certificate of Convenience and Necessity*. The *Order* directed Timber Creek to file compliance tariff sheets.

2. On August 8, 2022, Timber Creek filed tariff sheets with Tracking No. YS-2023-0034. After conversations with Staff, Timber Creek filed substitute tariff sheets to modify and revise the title of Sheet No. 2B on August 18, 2022.

3. On August 12, 2022, the Commission issued its *Order Directing Expedited Response to Compliance Tariff*. The *Order* directed Staff to file a recommendation regarding whether the tariff sheets comply with the Commission’s July 27, 2022 Order no later than August 22, 2022.

4. Staff has reviewed the tariff sheets listed below and recommends their approval:

P.S.C. MO No. 2, 2nd Revised Sheet No. 2A, Canceling 1st Revised Sheet No. 2A
P.S.C. MO No. 2, 2nd Revised Sheet No. 2B, Canceling 1st Revised Sheet No. 2B
P.S.C. MO No. 2, 2nd Revised Sheet No. 3A, Canceling 1st Revised Sheet No. 3A
P.S.C. MO No. 2, 2nd Revised Sheet No. 3B, Canceling 1st Revised Sheet No. 3B

WHEREFORE, Staff respectfully submits this Staff Recommendation to Approve Tariffs, and respectfully requests the Commission approve the tariffs filed by Timber Creek.






