Proposed Montebella Subdivision, Unincorporated Platte County Missouri

Dear Missouri Public Service Commission:

I was recently informed that an application was being submitted requesting rights to provide sanitary sewer service to an area currently within the boundaries of the Platte County Regional Sewer District (PCRSD).

The applicant is (Missouri) American Water Company. The service area is in the process of being platted as "Montebella" bordering the city of Riverside and lies in unincorporated Platte County.

PCRSD has a standing agreement with the City of Kansas City whereby sanitary sewage will be accepted from PCRSD for treatment when and if sanitary sewage collector lines are constructed. This agreement has been in force since 1995 and has been utilized on several occasions. This area will be serviced in the same manner.

RSMo 250.010 states, "I. In addition to all powers granted by law and now possessed by cities, towns and villages in this state for the protection of the public health, any city, town or village, whether organized under the general law or by special charter or constitutional charter, and any sewer district organized under chapter 249, RSMo, or sections 204.250 to 204.470, RSMo, as those chapters now exist, or as they may be amended, is hereby authorized to acquire, construct, improve or extend and to maintain and operate a sewerage system and to provide funds for the payment of the cost of such acquisition, construction, improvement or extension and operation as hereinafter provided. Such sewerage system may be constructed and operated either within or without the corporate boundaries of any such city, town or village or sewer district, but if it is within the corporate boundaries, it shall only be with the consent of the respective city, town, village or sewer district."

As the continuing authority for this area, PCRSD does not consent to sanitary sewer being provided in this area by parties other than Platte County Regional Sewer District.

Please keep me informed of any applications, correspondence, or pending actions regarding this area of service.
