**ORDER SETTING DEADLINES FOR OBJECTIONS AND
RECOMMENDATION ON COMPLIANCE TARIFF**

On September 14, 2016, the Commission issued an Order granting Central Rivers Wastewater Utility, Inc. (“Central Rivers”) Certificates of Convenience and Necessity to construct, install, own, operate, maintain, control, and manage sewer systems in Clay County, Missouri. In the order, which goes into effect on October 14, the Commission also directed Central Rivers to submit revised tariff sheets.

On September 29, Central Rivers filed tariff sheets (Tracking No: YS-2017-0045) with an October 29 effective date. The Commission will set a deadline for the Commission’s Staff to file a report on whether Central Rivers’ tariff sheets comply with the Commission’s September 14 Order. The Commission will also set a deadline for the filing of objections alleging the tariff sheets are not in compliance with the Commission’s Order.

THE COMMISSION ORDERS THAT:

1. No later than October 17, 2016, the Commission’s Staff shall file a report on the compliance of Central Rivers’ tariff sheets (Tracking No: YS-2017-0045) with the Commission’s September 14, 2016, Order Granting Certificates of Convenience and Necessity.

2. Objections to the compliance of Central River's tariff sheets (Tracking No: YS-2017-0045) shall be filed no later than October 18, 2016.

3. This order shall be effective when issued.
