**ORDER RESCHEDULING PREHEARING CONFERENCE**

On September 21, 2000, the Commission issued an order that, *inter alia*, set a date for a prehearing conference. On October 2, 2000, Ozark Telephone Company (the company) filed a pleading requesting that the Commission reschedule the prehearing conference to October 19, 2000, at 9:00 A.M. The company states that the change would be more convenient for, and allow a more efficient use of, its consultant. The company also requests that the due date for a proposed procedural schedule be October 26, 2000. The company states that the Staff of the Commission and the Office of the Public Counsel do not object to the proposed changes. The Commission will reschedule the prehearing conference and the due date for a proposed procedural schedule as requested.

1. That the prehearing conference will be held on October 19, 2000, at 9:00 A.M. The prehearing conference will be held at the offices of the Public Service Commission in Jefferson City, Missouri. This hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act. 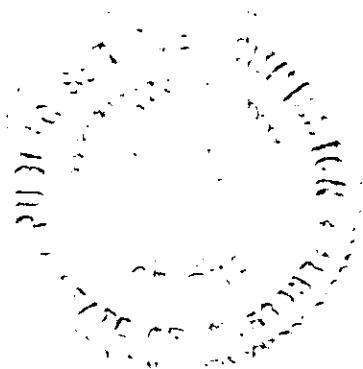


