ORDER RECOGNIZING CHANGE OF NAME

This order recognizes the name change of Nations Bell, Inc., to Nations Broadband, Inc., and approves the adoption notice reflecting that name change in the tariff.

On March 22, 2003, Nations Bell, Inc., filed a letter and an adoption notice notifying the Commission of the change of its corporate name from "Nations Bell, Inc." to "Nations Broadband, Inc." The proposed effective date of the adoption notice tariff is April 21, 2002. The company included with its filing a copy of its Certificate of Good Standing issued by the Missouri Secretary of State's office.

The Staff of the Missouri Public Service Commission filed its recommendation with an attached memorandum on April 9, 2002, stating that Staff had reviewed Nations Bell's request and had no objection to the change of corporate name. Staff stated that Nations Bell has met all of the requirements of Commission rule 4 CSR 240-2.060(16), and therefore, the Commission should approve the name change as reflected in the adoption notice.

The Commission has reviewed the filings and finds that the name change should be recognized and the proposed adoption notice should be approved.

IT IS THEREFORE ORDERED:

- 1. That the adopted name "Nations Broadband, Inc." is acknowledged.
- 2. That the adoption notice tariff sheet, Tariff File No. 200200801, filed on March 22, 2002, is approved and became effective on April 21, 2002.
 - 3. That this order shall become effective on April 22, 2002.
 - 4. That this case may be closed on April 23, 2002.
