# ORDER APPROVING INTEREXCHANGE AND NON-SWITCHED LOCAL EXCHANGE CERTIFICATES OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

Opex Communications, Inc. (Opex) applied to the Public Service Commission on July 9, 1999, for certificates of service authority to provide intrastate interexchange and non-switched local exchange telecommunications services in Missouri under Section 392.410-.450, RSMo 1994, and RSMo Supp. 1998<sup>1</sup>. Opex asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Opex is an Illinois corporation, with its principal office located at 500 East Higgins Road, Elk Grove Village, Illinois 60007.

The Commission issued a Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene on July 27, directing parties wishing to intervene to file their requests by August 11. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel. Rex Deffenderfer

Enterprises, Inc. v. Public Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

Opex filed a proposed tariff in conjunction with its application with a proposed effective date of August 23. Opex extended the effective date by letter to September 7. Substitute tariff sheets were filed on August 23. Opex's tariff describes the rates, rules, and regulations it intends to use, identifies Opex as a competitive company, and lists the waivers requested. Opex intends to provide interexchange and non-switched local exchange telecommunications services including 1+, 800/888/877, Directory Assistance, Private Line, and Travel Card services.

In its memorandum filed on August 26, the Staff of the Commission stated that Opex's proposed services are similar to existing interexchange telecommunications offerings. Staff recommended that the Commission grant Opex a certificate of interexchange service authority, and a certificate of service authority for local exchange telecommunication services on condition that this authority be restricted to providing dedicated, non-switched local exchange private line services. Staff recommended that the Commission grant Opex competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on September 7.

The Commission finds that competition in the intrastate interexchange and non-switched local exchange telecommunications markets is in the public interest and Opex should be granted certificates of service authority. The Commission finds that the services Opex proposes to offer are competitive and Opex should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that Opex's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange and non-switched local exchange carriers. The Commission finds that the proposed tariff filed on July 9 shall be approved as amended to become effective on September 7.

#### IT IS THEREFORE ORDERED:

- 1. That Opex Communications, Inc., is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to the conditions of certification set out above.
- 2. That Opex Communications, Inc., is granted a certificate of service authority to provide local exchange telecommunications services in the state of Missouri limited to providing dedicated, non-switched local exchange private line services, subject to all applicable statutes and Commission rules except as specified in this order.

3. That Opex Communications, Inc., is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
