ORDER APPROVING TARIFF PURSUANT TO COMMISSION ORDER

On August 20, 1996, the Commission issued its order in this matter, granting a certificate of convenience and necessity to Spokane Highlands Water Company (Highlands) to construct and operate a public water supply system in an unincorporated area of Christian County, Missouri. Highlands was required to file tariffs in accordance with that order prior to commencing operations. On September 6, 1996, Highlands filed complete tariffs for the provision of water service, with an effective date of October 1, 1996, later amended to October 6, 1996. At the request of the Staff of the Commission (Staff), Highlands filed a substitute sheet on September 19, 1996, to correct typographical errors.

On September 20, 1996, the Staff of the Commission (Staff) filed its recommendation, stating that, after review, the Staff considered the tariffs reasonable and in compliance with the Commission's order of August 20, 1996. The Staff recommended approval of the tariffs, as corrected.

The Commission has reviewed the tariff filing of Highlands, as substituted, and the recommendation of the Staff, and finds the tariffs to be reasonable and in full compliance with the Commission's order of August 20, 1996. The Commission will approve the tariffs for service on or after October 6, 1996.

IT IS THEREFORE ORDERED:

1. That the following tariffs, filed September 6, 1996, by Spokane Highlands Water Company, as substituted, are hereby approved for service on or after October 6, 1996:

2. That this order shall become effective October 6, 1996.
