

APPLICATION

Paramount International Telecommunications, Inc. d/b/a R Network ("Paramount International" or "Applicant"), by its undersigned counsel and pursuant to Section 392.460 of the Missouri Revised Statutes, MO. REV. STAT. § 392.460, hereby respectfully requests that the Commission issue an order canceling Paramount International's Certificate of Service Authority currently on file with the Commission.

Paramount International submits the following information in support of this Application:

1. Paramount International is a Nevada corporation headquartered in Vista, California. Paramount International is authorized to provide private payphone services in the State of Missouri pursuant to a Certificate of Service Authority granted by the Commission in Case No. TA-2000-457 ("Certificate"). Paramount International's certificate of authority to do business from the Missouri secretary of state was provided in Case No. TA-2000-457. Pursuant to 4 CSR 240-2.060(G), Paramount International requests that the certificate be incorporated by reference herein.

2. Paramount International does not provide telecommunications services to any customers in the State of Missouri and has no outstanding obligations to any Missouri customers in the form of deposits or pre-payments for services which have not or will not be provided.

3. Paramount International does not intend to operate as a provider of intrastate telecommunications services in Missouri and, therefore, desires to surrender its Certificate effective as soon as possible.

4. In connection with this Application, Paramount International withdraws and therefore also requests cancellation of its Missouri certificate currently on file with the Commission.


5. Any requirement to give prior written notice to customers of Paramount International's surrender of its Certificate is inapplicable in this instance because Paramount International has no customers in Missouri.

6. Paramount International submits that the surrender of its Certificate is reasonable, necessary and not disruptive to the present or future public interest, convenience and necessity of the State of Missouri.

7. Pursuant to 4 CSR 240-2.060(1)(K) & (L), Paramount International states that it does not have any pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of the application. Paramount International does not, to the best of its knowledge, have any overdue annual reports or assessment fees in Missouri.

WHEREFORE, Paramount International respectfully requests that the Commission grant this Application and issue an Order canceling its Certificate currently on file with the Commission.




