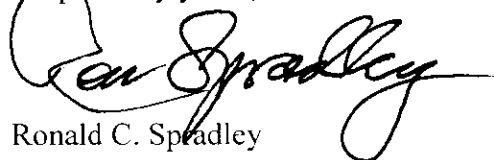
Dear Mr. Dale:

Comes now, The Raytown Water Company (Applicant) pursuant to 4CSR 240-2.060 and 4 CSR 240-10.080(8) and submits its written request to extend the filing date for its Annual Report to and including June 15, 2007. In support of this application for extension Applicant states as follows:

1. The Applicant is a Missouri water corporation as defined in Chapter 386 of the Missouri Revised Statutes and subject to the jurisdiction of the Missouri Public Service Commission (the "Commission"). 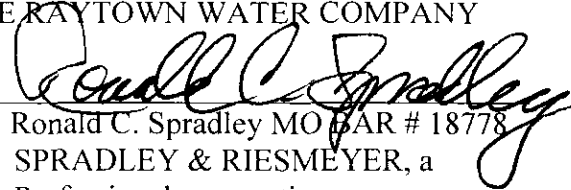

3. Applicant is a very small investor-owned water utility and utilizes the accounting services of a certified public accountant, David Aldridge, of Marr & Company, P.C., a small accounting firm.
4. Marr & Company, in the course of preparing the 2006 federal and state income tax returns for the Company, have advised the Company that they needed to file for an extension with the Internal Revenue Service for filing the 2006 returns, as they were not able to complete preparation of the returns for filing by them by the IRS filing date. They have advised the Company that they cannot prepare the Annual Report for 2006 for filing with the Commission until the 2006 income tax returns are completed for filing, as certain final information from the tax returns is necessary to complete the Company's Annual Report. All of this can be completed on or before June 15, 2007.
5. There are no annual reports or assessments overdue by the Company.
6. The undersigned is not aware of any pending cases before the Commission where the Company's activities are the primary focus of the proceeding.

WHEREFORE, Applicant respectfully requests that the Commission issue an order or decision granting Applicant an extension of time to and including June 15, 2007 to file its Annual Report for the year 2006.

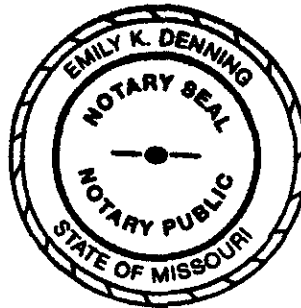
