ORDER APPROVING COMPLIANCE TARIFF SHEETS

On September 29, 2016, Central Rivers Wastewater Utility, Inc. ("Central Rivers") filed tariff sheets (Tracking No: YS-2017-0045) in compliance with the Commission's *Order Granting Certificates of Convenience and Necessity* ("Order"). The Commission issued an order directing the Commission's Staff to file a recommendation on Central Rivers' tariff sheets and setting an October 18 deadline for the filing of objections to the company's tariff sheets. No objections were received.

The Commission's Staff filed its *Recommendation* on October 17. Staff states that after a full review it has determined that the tariff sheets are in full compliance with the Commission's Order. Staff recommends the approval of Central Rivers' tariff sheets. Upon review of the filings, the Commission finds that Central Rivers' tariff sheets comply with the Commission's Order. The Commission will approve the tariffs sheets to go into effect on October 29, 2016.
